# Local Law No.5 (Parking) 2011

Local Law No. 5 is about parking and traffic areas in region.

This document is a summary of the local law and cannot be treated as a substitute for the local law. The local law and subordinate local law may be read in full at frasercoast.qld.gov.au/local-laws.

## You may be impacted by this law if you...

- drive a car
- are a passenger in a car
- walk across pedestrian crossings and use footpaths
- use taxi ranks or bus stops.

#### What this law covers

- 1. Preliminaries: The purpose of Local Law No. 5 is to enable Council to take action in line with the parking regulations of the TORUM Act - the Transport Operations (Road Use Management) Act 1995 which is state government legislation.
- 2. Declaration of parking areas: Council can declare traffic areas and off-street regulated parking areas.
- 3. Parking contrary to parking restriction: Council can issue parking permits; for example, for people with disabilities, and commercial vehicle identification labels.
- 4. Minor traffic infringment penality notice: Council can set the penalty rates for parking offences that are enforced by Council.

# What is in the schedules (ie what it applies to)

Schedule 1 is for the declaration of traffic areas; however, there are no traffic areas declared in the region.

Schedule 2 is a collection of maps showing all of the off-street regulated parking areas in the region including metered carparks and parking for boat ramps and community halls. There are 31 maps.

Schedule 3 lists all of the minor traffic offences (parking offences) that Council can issue a fine for, along with the penalty amount for each offence. The penalty amount is in "penalty units" such as 0.5 of a penalty unit. There are 39 offences listed. The penalties range between 0.5 and 2 penalty units.
